"1. In accordance with Article 62, the Republic of Paraguay makes the reservation, with respect to Article 2 (2), that it reserves the right to limit the application of the Convention in respect of sub-paragraph 1 (a) of Article 2 to persons who have not attained the age of 18 years.

2. In accordance with Article 63, the Republic of Paraguay declares that, with respect to Article 2 (3), it will extend the application of the Convention with respect to other maintenance obligations arising from a family relationship, parentage, marriage or affinity, including in particular obligations in respect of vulnerable persons."
